

SWIMMING POOL RULES

These rules and regulations are designed for the safety and convenience of our members and their guests and are established to comply with the Kentucky public swimming pool regulations as issued by the Kentucky and Jefferson County Departments of Health. Members will be primarily responsible for the observance of these rules by their guests as well as themselves. Any member disregarding these rules will be subject to appropriate disciplinary action. The Club will not be responsible for any injuries suffered through negligence or violation of rules.

1. **Hours of Operation** – Tuesdays, Wednesdays and Thursdays: 10:00 a.m. – 9:00 p.m. // Fridays and Saturdays: 10:00 a.m. – 9:30 p.m. // Sundays: 11:00 a.m. – 8:00 p.m. The pool is cleared 15 minutes prior to closing and times may be adjusted based on seasonal changes. Please refer to the HCC mobile app for inclement weather closures.
2. **Guest Fees and Rules** – Guests are welcome at the pool and must be accompanied by a member at all times and must sign in at the guest register. The member is responsible for paying the guest's fee. Guest fees: adults: \$10, children ages 3-12 and family guests: \$5. Family guests are defined as parents, adult children, grandchildren, siblings, nieces, nephews and in-laws of current members. Guests may not visit the pool more than four (4) times in a month. No member shall have more than three (3) guests at the pool without prior approval.
3. **Food and Beverages** – Food and beverages are available for purchase through the snack bar. Only food and beverages purchased from the Club may be consumed on Club premises. Please be mindful to pickup your area after use and place trash in appropriate receptacles.
4. **Nanny/Babysitter** – Anyone using a nanny or full-time babysitter can pay a seasonal \$100 fee or \$10 per visit. The nanny/babysitter seasonal pass sign-up form is located on the Pool page of the website.
5. **Lightning/Thunder** – At the sight of lightning and/or sound of thunder, the pool will be cleared until there has been a period of no lightning or thunder for at least 20 minutes. If severe weather persists, the Club may close the pool.
6. **Rules of the Pool**
 - a. No swimmer will be allowed to enter the pool unless clothed in customary swimming attire. Persons in swimming attire will not be permitted in the Thoroughbred Grill, 1854 Dining Room, Hunt Lounge, Soldier's Retreat, private rooms, porches or Pro Shop. The men's and women's locker rooms may be used to change into swimming attire as desired, but children under 18 years of age must use the bathhouse facilities.
 - b. Swimmers may not enter the pool facility if there is no lifeguard on duty.
 - c. All swimmers shall be required to shower prior to entering the pool. The bathhouse showers should be used for this purpose by all swimmers.
 - d. Non-swimmers must wear an approved personal flotation device and be accompanied by an adult.

- e. An adult or guardian (age 18+) must accompany all children under 12 years of age. Children under 12 may not be left unattended at the Club.
- f. Members are responsible for all children in the baby pool. You must be with your child always. The baby pool is for the use of children ages 6 and younger.
- g. The lifeguards are responsible for safety, sanitary measures and the protection of your children and your guests. The lifeguards have full authority to maintain order at the pool. They may reprimand, discipline, restrict and evict any individual not complying with these rules.
- h. Everyone must leave the pool in the event of an emergency (including inclement weather such as thunder and lightning).
- i. Foul and abusive language will not be permitted at the pool.
- j. Children who are not potty trained are required to wear a swim diaper in the pool.
- k. Diving rules: Diving will be conducted only in areas where the water depth and conditions will safely allow such activity. Only one diver at a time on the board; no diving until the previous diver has moved to the side of the pool. All divers must go straight off the front of the board. No flotation devices may be used on the diving board. No swimmer is permitted to climb or dive from the lifeguard chair at any time. No diving and no flips from the side(s) of the pool at any time.
- l. No running, boisterousness or rough play, including throwing others into the pool, will be permitted in the pool or at any part of the pool facility.
- m. Members and their guests are not permitted to leave the pool area with HCC towels. Kindly place used towels in the appropriate bins as you leave the pool area.
- n. No outside food or beverage is permitted on HCC property.
- o. Children of all ages are NOT permitted to play outside of the swimming pool area with the exception of the Box Court Lawn.
- p. Lifeguards have full authority to control the use of toys or other objects in the pool. No floating supporters or objects are to be used in the deep diving area of the pool.
- q. No standing directly in front of the lifeguard chair. Lifeguards must always have full view of the pool and may need to enter the water at any time for a rescue.
- r. No drinking glasses or glass objects will be permitted anywhere in the pool area.
- s. Use of tobacco, including smokeless, and vaping devices is not permitted in the pool area.
- t. No person under the influence of alcohol or drugs should use the pool.
- u. Swimming and diving lessons are available to HCC members only. The swimming coaches will give lessons by appointment. Please check the bulletin board at the pool house for contact information.
- v. No pets will be allowed inside the swimming pool area at any time.
- w. All county pool regulations will be strictly enforced. The following rules shall also be observed:
 - 1. Any person having skin disease, sore or inflamed eyes, nasal or ear discharge or any communicable disease shall not enter the pool.
 - 2. Persons with exposed subepidermal tissue, open blisters, cuts, etc., are strongly advised to not use the pool.
 - 3. Spitting, spouting of water, blowing the nose or other unsanitary acts in the pool are strictly prohibited.
- x. The Club is not responsible for any items misplaced or stolen. Please check lost and found frequently for lost items.

SWIM & DIVE TEAM RULES

The Hurstbourne swim & dive team is part of the CCSA and follow the CCSA rules and swim team schedules. Children may participate from age 3 through 18. We have two CCSA representatives who volunteer their time and efforts each season. The swim & dive team use the pool daily for practice, all times are posted. Please refer to swim & dive team schedules posted on the HCC website and on the bulletin board at the pool house.

1. Swim and Dive Team Practice (SUBJECT TO CHANGE)

- a. **Tuesday / Thursday / Saturday:** Swim (10 & under, 12 & under, and 13 & older) 9:00 – 10:15 a.m. / Swim (6 & under, and 8 & under) 10:15 – 11:00 a.m. Dive (10 & under, 12 & under, and 13 & older): 10:30 – 11:15 a.m. / Dive (6 & under, and 8 & under) 11:15 a.m. – 12:00 p.m.
- b. **Wednesday / Friday:** Swim (10 & under, 12 & under, and 13 & older) 4:00 – 5:00 p.m. / Swim (6 & under, and 8 & under) 5:00 – 5:45 p.m. Dive (10 & under, 12 & under, and 13 & older): 5:15 – 6:00 p.m. / Dive (6 & under, and 8 & under) 6:00 – 6:45 p.m.

2. **Swim and Dive Meets** – Swim meets are held on Sundays. During home meets, members are granted use of the opposing team's club without guest fees, as reciprocity for hosting.

3. **Grandchildren** – Grandchildren of members are granted full privileges to swim in CCSA swim & dive events. A member's grandchildren may generally participate in the swim & dive program from age 3 until the age of 18, or upon completion of the individual's senior year of high school. Grandchildren participants are entitled to use the Club's swim facilities for all practices, meets and program sponsored social events. Swimmers may also utilize the Club's swim facilities for a period of one hour prior to and after the conclusion of swim practice or events; or may sign in as a guest with the accompaniment of a member. All other membership limitations apply for extended or additional visits.
